Makarenko V.P. Weltanschauung Machine: the Motor-car Enthusiast's Reflections.

Summary: The paper shows there are two religious-philosophical premise for the common belief in the immortality of man: first, the eternity is manifested in human history and life as an Absolute which is constructed by the human consciousness and attributed to the Being; second, this Absolute ('God' or its abstract substitute) is described in anthropological terms. The problem is shifted to the typology of concepts during the "proof" of these assumptions and the resulting Weltanschauung schemes. The author examines the genesis of these concepts in the history of philosophy.

In this context, the essence of "the logic of hegemonic formation" is critically examined. Further, the author assesses the methodological potential and contemporary political context of "radical" and "agonistic" democracy.

Oleinik A.N. On the Origins of Administrative Rent: Doing Business in a Russian Region

Summary: Two types of rent are differentiated: resource rent and administrative rent. The latter is linked to restrictions on the access to the field of interactions. The contribution of the theory of public choice and the theory of rent-seeking and directly-unproductive activities is further developed by shifting the emphasis from individual decision-making to interactions between three actors: \underline{C} , who controls access to the field, \underline{A} , who gets a competitive edge as a result, and \underline{B} , who assumes a subjacent position with regard to both \underline{A} and \underline{C} yet still receives a positive gain from transacting. Domination by virtue of a constellation of \underline{A} 's, \underline{B} 's, and \underline{C} 's interests works is illustrated with the help of an in-depth case study of a Russian region. This study combines quantitative (econometric modeling) and qualitative (content-analysis of 26 semi-structured interviews conducted in 2006-2008) methods, as well as their triangulation.


